

Monroe “Get a Grip on Safety” Trade Promotion Terms & Conditions – MAY - 2025

1. The Promoter is Monroe Australia Pty Ltd, 1326 South Road, Clovelly Park, SA 5042. ABN 68 007 525 386. (“Promoter”)
2. Information on how to enter in the promotion form part of these conditions. Entry into the promotion is deemed acceptance of these conditions by each participant.
3. Standard GPC trade promotion terms and conditions apply including Repco T&C and NAPA T&C and the promotion is only valid for Monroe purchases from REPCO and NAPA.
4. This Competition is only open to Trade Account customers only who:
 - a) are operating within Australia and are aged 18 years or older;
 - b) have not been discovered to have breached these Terms and Conditions
5. The promotion period is 5 weeks commencing from 12:01AM AEDT on 1st May 2025 to 11:59PM AEDT 31st May 2025. (“Promotion Period”) The weeks are defined as following;
 - a) Week 1 - 01st May to 10th May 2025
 - b) Week 2 - 11th May to 17th May 2025
 - c) Week 3 - 18th May to 24th May 2025
 - d) Week 4 - 25th May to 31st May 2025
6. **Prizes:** The prize is a OZPig portable Wood Stove valued approximately at ~\$370 each. Total of 80 prizes to be won during the promotion which includes 60 prizes for Repco and 20 Prizes for NAPA.
7. Prizes are not transferable, saleable or exchangeable and cannot be taken or redeemed as cash or equivalent.
8. The Promoter makes no warranties, representations or guarantees, express or implied, in fact or in law, in relation to this Competition or the merchantability, quality or fitness for a particular purpose regarding any prize or any component of any prize.
9. **How it works:** Customers who spend a minimum of \$200 per week (*net of returns), every week for all four weeks of the promotional period (as outlined in Point 5) will be eligible to win the prize, awarded on a first-come, first-served basis.
 - a) Repco - First 60 qualifying customers = Total of 60 winners
 - b) NAPA - First 20 qualifying customers = Total of 20 winners

12. **Winner Notifications :** Winners will be notified via call or through Repco Auto Parts/NAPA stores or Monroe Sales Team within 14 days of the winner selection. The prizes will be delivered within 45 days of notification.
13. **Winner Conditions :** Maximum limit of 1 Prize per workshop for the promotion period. Max of 80 winners across all Repco/Napa.
14. No responsibility will be accepted by the Promoter for late, lost or misdirected registrations.
15. If there is a dispute as to the identity or details of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity or details of the entrant.
